

Clark County Credit Union Gas Card Giveaway

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.

A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. WINNERS WILL BE CHOSEN AT RANDOM.

By entering the Clark County Credit Union Gas Card Giveaway (the "Sweepstakes"), you agree to comply with and be bound by the following Official Sweepstakes Rules (the "Official Rules"). If you do not agree with the Official Rules in their entirety, you are not permitted to enter the Sweepstakes.

ELIGIBILITY: THE SWEEPSTAKES IS OPEN ONLY TO PERMANENT LEGAL RESIDENTS OF THE 50 UNITED STATES or THE DISTRICT OF COLUMBIA, WHO ARE 18 OR OLDER at the time of entry. Employees of Clark County Credit Union (CCCU), ("Sponsor and Administrator") and their parent companies, subsidiaries, affiliates, advertising and promotion agencies and their immediate family members (defined as spouse, siblings, parents and children) and/or those living in the same household (whether related or not) of each are eligible to enter. Sweepstakes is subject to all applicable federal, state, local and provincial laws and regulations, and is void where prohibited by law. The information provided will only be used for the purposes of this Sweepstakes and as otherwise permitted by Sponsor's privacy policy.

SWEEPSTAKES TIMING: The Sweepstakes begins 12:00am PDT on 10/23/2020 and 11:59 pm PST on 11/30/2020 (the "Entry Period"). Within the Entry Period, there are four (4) Entry Periods (each, an "Entry Period") and four (4) corresponding Random Drawings (each, a "Drawing") as defined in the "Entry Periods & Drawing Schedule" below. Entries must be received during an Entry Period to be eligible for that Entry Period's drawing and prize. Non-winning entries for an Entry Period will **not** roll over to the subsequent Entry Period. Sponsor's database clock will be the official timekeeper for the Sweepstakes.

HOW TO ENTER: There is one (1) method of entry.

To enter, fund a refinance vehicle loan or new loan purchase with Clark County Credit Union (CCCU) (the "Entry"). Entries must be received between 12:00am PDT on 10/23/2020 and 11:59 pm PST on 11/30/2020 (the "Entry Period") to be eligible.

Eligible entries are defined as loans signed for and funded within the entry period. Selected entry in each entry drawing period must be a member in good standing to accept prize. Requirement also applies to second chance entries. Each loan number will be considered one (1) entry.

PRIZES & APPROXIMATE RETAIL VALUE ("ARV")/ODDS: There are five (5) Prizes available to be won; five (5) Gas Gift Cards. Each winner will be awarded one (1) \$500 gas gift card, each with an ARV of \$500. **The total ARV of all prizes available to be won is: \$2500.00.** There is a limit of one (1) prize per person. Odds of winning a Prize depend on the number of eligible entries received per Entry Period. Gas gift cards are not redeemable for cash and will not be replaced if lost or stolen. Gift card usage is subject to the complete gift card terms and conditions on the back of the gift card.

WINNER SELECTION/NOTIFICATION: The Sweepstakes is under the administration of the Administrator; whose decisions are final. Potential winners will be selected in a series of random drawings from among all eligible entries received within each Entry Period on or about the corresponding Drawing date indicated in the Entry Period & Drawing Schedule above. Potential winners will be notified by phone and phone on or about the corresponding Drawing date and will be requested to verify his/her eligibility by signing and returning, within seven (7) days of this formal notification by Administrator, an Affidavit of Eligibility and a Liability Waiver, a W-9 Form and, where allowable, a Publicity Release (collectively, "the Releases"). Noncompliance will result in disqualification and an alternate winner being selected. Winners are responsible for all applicable federal, state, or local income taxes associated with winning the prize. Winners may be required to furnish his/her social security number for the sole purpose of preparation of any tax forms as required by law.

SECOND CHANCE DRAWING: A prize that has not been claimed or has been forfeited due to causes, including, but not limited to, ineligibility of potential winner or returned email, will be included in a Second Chance Drawing for such unclaimed prize. Second Chance Drawings will be conducted via random drawing from among all eligible entries received which have not otherwise received a prize in the Sweepstakes, for each applicable Entry Period on or about the Second Chance Drawing Dates indicated in the Entry Period & Drawing Schedule above. Potential Winners selected in any Second Chance Drawing will be contacted within 48 hours after such Second Chance Drawing.

The potential Second Chance Winners, if any, will be notified by email and phone and will be requested to verify his/her eligibility by signing and returning the Releases, within seven (7) days of this formal notification by Administrator. Noncompliance will result in disqualification and an alternate winner may be selected. Winners are responsible for all applicable federal, state, and local income taxes associated with winning the prize.

PRIZE CONDITIONS: If a winner is otherwise eligible under these Official Rules, but is nevertheless deemed a minor in his or her state of primary residence, the prize will be awarded in the name of winner's parent or legal guardian who will be required to execute and return the Releases on minor's behalf.
